Camp Fitz John Porter and the man it was named after:

The 140th New York Volunteer Infantry Regiment organized and drilled at Camp Fitz-John Porter on the western bank of the Genesee River in Rochester, NY. Camp Fitz-John Porter was also the mustering location for the 108th New York Volunteer Infantry Regiment, and Mack's 18th New York Independent Artillery Battery.

**Fitz John Porter** (August 31, 1822 – May 21, 1901) (sometimes written **Fitz John Porter** or **Fitz-John Porter**) was a career United States Army officer and a Union general during the American Civil War. He is most known for his performance at the Second Battle of Bull Run and his subsequent court martial.

Although Porter served well in the early battles of the Civil War, his military career was ruined by the controversial trial, which was called by his political rivals. After the war, he worked for almost 25 years to restore his tarnished reputation and was finally restored to the army's roll.

In 1862, Camp Fitz-John Porter was established in Monroe County, NY, one mile south of Rochester, NY, on the western bank of the Genesee River. The camp was the mustering location for the 108th New York Volunteer Infantry Regiment the 140th New York Volunteer Infantry Regiment and Mack's 18th Independent "Black Horse" artillery battery. · In 1904, a statue of Porter designed by artist James E. Kelly was dedicated in Haven Park in Portsmouth, New Hampshire.

In World War II, the United States liberty ship SS *FitzJohn Porter* was named in his honor. Porterstown Road in the town by the same name runs directly through the area where his forces were placed for the Battle of Sharpsburg.

His Portsmouth home is listed on the National Register of Historic Places.
